Subject: Release of Grant in aid of 1st installment under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (PMJVK) for Minority Concentration Areas (MCAs) to Government of **Mizoram for 2023-24.**

Sir,

I am directed to convey sanction of the President for release of an amount of Rs. **10,00,00,000/- (Rupees Ten Crore Only)** to the Govt. of Mizoram as 1<sup>st</sup> Installment during FY 2023-24 for implementation of ongoing projects under "Mantri Jan Vikas Karyakram (PMJVK)" in the State of Mizoram.

2. The sanction is being issued as per para 12 of Ministry of Finance O.M. No. 1 (13)PFMS/FCD/2020 dated 21.03.2021 regarding "Procedure for release of funds under the Centrally Sponsored Schemes (CSS) and monitoring utilization of the funds released.

3. The expenditure is debitable to Demand No.70, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64-Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.35 Grant for creation of capital assets the year 2023-24.

4. The above release of funds to the State of Mizoram is subject to the following condition:

- i. The funding pattern between Centre and State is 90:10 for PMJVK.
- ii. 2<sup>nd</sup> Installment of funds during 2023-24 will be released only after due confirmation for release of 1<sup>st</sup> Installment (along with matching State Share) to the SLNA by the State Government, along with Utilisation Certificate.
- iii. Funds in the bank account of SNA will not be tied to any project and will form a common pool. The Expenditure from the bank account of SNA will be as per MoMA's guidelines issued vide letter No. MsDP-21/47/2020-MsDP-MoMA dated 06.12.2020.
- iv. Administrative expenditure under the scheme should not exceed the ceiling of 2% of the actual expenditure.
- v. The State Government should ensure to minimize the unspent balance for all projects under the scheme, to upload the QPRs on the PMJVK Portal and to update MIS regularly. State shall ensure geo-tagging of all projects on PMJVK-Bhuvan app.
- vi. Funds should be released by the State Govt. to the implementing agencies as per the guidelines of Department of Expenditure, Ministry of Finance, Govt. of India issued from time to time and ; parking of funds at any level is strictly prohibited.

- vii. PMJVK being Centrally Sponsored Scheme (CSS), the State Government should strictly follow the revised procedure of funds flow as per instruction issued by the DoE, M/o Finance, GoI vide OM No. 1(13)PFMS/FCD/2020 dated 21.03.2021 as amended/Modified from time to time.
- viii. Utilization of the above mentioned amount by the State Government is subject to the other terms and condition at Annexure-I.

5. The State Government shall transfer these funds along with the corresponding State Share to the bank account of State Nodal Agency for PMJVK immediately under Intimation to the Ministry.
6. Utilization Certificate for this grant should be submitted by the State in the prescribed format as per the scheme guidelines.
7. The funds will be utilized for the purpose for which these are sanctioned and as per the revised PMJVK scheme guidelines; otherwise funds will have to be refunded along with the interest as per provision in GFR 2017.
8. This is to certify that the present sanction/ expenditure is covered under MEP for the month of December, 2023 and Integrated Finance Division (IFD) has approved the expenditure during the 3rd quarter of the financial year 2023-24.
9. The amount will be credited to the State Govt. account in RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM. No. 1(13)PFMS/FCD/2020 dated 23.03.2021.
10. This sanction issues with concurrence of IFD Note No. #66 dated 30.12.2023 of File no. 13/49/2021-MsDP-MoMA. It is noted at S. No. 03 in the Grant-in-aid Register 2023-24.

- i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
- ii. All release by the State/UT should be made through PFMS and EAT module only.
- iii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
- iv. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- v. Grantee shall not divert any part of the grant to any other activities.
- vi. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vii. Grantee shall endeavor to achieve the quantified and qualitative targets.
- viii. Grantee will ensure that there is no duplication of work.
- ix. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
