Shri T.Gupta IAS DC,pre'sided over the meeting . At the very outset , the scale of pay of all Gazetted Officers of Group "A" & "B" catogaries in the 3- District Councils were examined :-

After elaborate discussion,the Committee agreed that:

(1) Constitution of common cadres : There will be to common cadres in District Council services viz Group "A" cadres and "B" cadres to known as District Council General Services Group - "A" & "B"

(2) Constitution of grades in the services : In the Group - "A" services there will be three grades viz; Entry grade, Senior grade, and Selection grade.The scale of pay of each grades will be as follows :

(i) Entry grade : The initial starting pay of the group - "A" officers in the first entry will be 650 - 1200/= P.M.

(ii) Senior grade : After completion of 8 years services,the officer after screening his performances desires by the Department promotion committee will be promoted to the Senior grade in the scale of pay Rs. 900 - 1400/= P.M.

(iii) Selection grade : On completion of 15 years services, the officer will be promoted to Selection grade with the scale of pay of Rs. 1200 - 1600/= P.M.

(iv)As for Executive Secretary, the officer will given a special pay of Rs. 100/=P.M. addition to his own grade pay.

(3) Recruitment :- Minimum qualification required for the post of group - "A" officers will be a degree from any recognized University and Selection will made as follows :-

(1) 50% direct recruitment.

(2) 50% promotion from group - "B" on seniority cum-merit.

(4) Group - "B" grades :- The scale of pay of general services group - "B" will be Rs. 550 - 900/= P.M.

Recruitment : The minimum qualification for the post of group - "B" Officers except for the post of O/S will be a degree from any recognized University will be made by promotion from Assistant. On Seniority cum-merit basis.

(5) Also the came of existing incumbents who are presently holding group - "A" & "B" posts but under qualified was examined. Since these officers are promoted on the basis Seniority cum-efficiency and as they have put 10 to 15 years in the services,the committee resolved that these case will be referred to the Govt. for consideration of educational qualification. The District Council authority may submit such cases with details particulars of the concerned officers.
