No.A.26020/1/93-DCA, the 9th June, 2003. In pursuance of paragraph 11 of the Sixth Schedule to the Constitution of India, the following Rules of Lai Autonomous District Council which received the approval of the Governor of Mizoram is hereby published for General information.

THE LAI AUTONOMOUS DISTRICT COUNCIL (SALARIES AND ALLOWANCES OF CHAIRMAN & DEPUTY CHAIRMAN) RULES,2003

ARULES

To provide for the salaries and allowances of the Chairman and Deputy Chairman of the Lai Autonomous District Council.

Be it enacted by the Lai Autonomous District Council in the Fifty-Second Year of the Republic of India as follows:-

Short title 1. (1) These Rules may be called the Lai Autonomous District Counand comcil (Salaries and Allowances of the Chairman and the Deputy mencement Chairman) Rules, 2003

- (2) It shall be deemed to have come into force with effect from the 23rd May, 2001.
- In these Rules, unless the context otherwise requires :-Definitions 2.
 - (a) "Chairman" means the Chairman of the Lai Autonomous District Council;
 - (b) "Deputy Chairman" n.eans the Deputy Chairman of the Lai Autonomous District Council;
 - (c) "District Council" means the District Council of the Lai Autonomous District;
 - (d) "family" in relation to the Chairman and the Deputy Chairman means the wife residing with him and the legitimate children and step-children wholly dependent on him and where the husband has more than one wife, only one wife shall be included in his family;
 - (e) "Government" means the Government of Mizoram;
 - (f) "he" and its grammatical variation stand for both man and woman;
 - (g) "Travelling Allowances" means the allowances granted to the Chairman and the Deputy Chairman under these Rules to cover the expenses which he incurs in travelling in the interest of public services;
 - (h) "Schedule" means the Schedule appended to this Rule.

- Salaries of 3. There shall be paid to the Chairman and the Deputy Chairman Chairman a salary of rupees ten thousand each per mensem.

- Sumptuary 4. There shall be paid to the Chairman and the Deputy Chairman a sumptuary allowances of four thousand five hundred rupees each per mensem, family allowances of four thousand five hundred rupees allowances each per mensem and the entertainment allowances of four thousand rupees and three thousand five hundred rupees respectively.
- Resident and furni-shing of residence.
- 5. The Chairman and the Deputy Chairman shall be entitled without any payment to the use and maintenance of a furnished residence throughout their term of Office and for a period of fifteen days immediately thereafter; and so long as such residence is not provided he shall be entieltd to a residence for which rental charge shall not be more than three thousand five hundred rupees per measurement and there shall be made available a sum of Rs. 40,000/(rupees forty thousand) only for furnishing residence for the first year and Rs. 5,000/- (Rupees five thousand) only annually for the subsequent years.

EXPLANATION:

- "Maintenance" in relation to a residence includes :-
- (i) Provision of electricity and free water supply.
- (ii) Provision of free Telephone calls and
- (iii) Payment of local rates and taxes.

Conveyance 6. The Chairman and the Deputy Chairman shall be entitled to the free use of motor vehicle, the entire cost of maintenance and propulsion alongwith the service of chauffeur which shall be borne by the District Council.

Travelling and Daily

- 7. Subject to the provision of the Schedule the Chairman and the Deputy Chairman shall be entitled to:
- Allowances (a) Travelling allowances for the transport of personal effect of of himself and his family in respect of journey to Lawagtlai from his usual place of residence for the purpose of assuming office and demitting office.
 - (b) Travelling and daily allowances in respect of tour undertaken by him in the discharge of his official duties whether by land or by air.

Medical

8. The Chairman and the Deputy Chairman and the members of their family shall be entitled free of charge to accommodation in Hospital, Nursing Homes and clinics recognised by the District Council and also to medical treatment, consultation fees and diet charges with one Medical Attendant in case he is admitted to a Hospital.

Chairman Chairman allowances

9. No person in respect of a salary or allowances under this Rule and Deputy shall be entitled to receive any sum out of the funds provided by the District Council by way of salary or allowances in respect of not to draw their membership of the District Council.

Notification 10. The date on which any person become or ceased to be a Chair-respecting man or Deputy Chairman shall be published in the Mizoram Ga-election of zette and any such notification shall be conclusive evidence of the Chairman fact that he become, or ceased to be Chairman or Deputy Chair and Deputy man on that date for the purposes of this Rule.

Discretionary fund 11. The Chairman shall be provided every year in the Budget a a discretionary fund of the same amount with that of the Chief Executive Member and the Deputy Chairman equal to the amount provided for the Executive Member.

Household staff

12. The Chairman and the Deputy Chairman shall be entitled to Grade-IV Staff of three and two numbers respectively of his choice as Household staff on a fixed pay of Rs. 3000/- the appointment of them shall be co-terminus without yearly increment.

Repeal

- 13. (1) The Lai Autonomous District (Salaries and Allowances of and Saving Chairman and Deputy Chairman) Act, 1993 is hereby repealed.
 - (2) Notwithstanding such repeal, anything done or any action taken under the Act so repealed shall, in so far as it is not inconsistent with the provision of this Rule be deemed to have been done or taken under this Rule.

THE SCHEDULE (See Rule - 7)

Travelling on duty

1. When travelling on duty by railway or by road or steamer or by air a Chairman or a Deputy Chairman shall be entitled to re in burse the actual fare of journey including incidental charge and daily allowances of Rs. 250/- within Mizoram and Rs. 300/- outside Mızoram.

The Travel- 2. In respect of Journey to Lawngtlai from his usual place of residence for assuming or from Lawngtlai to his usual place of residence on demitting office, a Chairman and a Deputy Chairman is entitled to travelling allowances towards the cost of transporting himself of his family and family's effects.

Travelling by air

- 3. (1) The Chairman or the Deputy Chairman may in public interest, perform journey on tour by air in public tour transport services.
- (2) On the cancellation of a journey to official reason, a Chairman or a Deputy Chairman shall be entitled to be re-imbursed by the District Council any deduction made by the air transport ser-vices when refunding the fare on account of cancellation of the air passage.
- (3) The Chairman or the Deputy Chairman who does not utilise the free transport service between the air booking centre and the airport may also recover in respect of journey to and from the airport actual travelling expenses or road mileage as for journey on duty by road whichever is less.

Accommodation 4. Where no Government accommodation is available Chairman or Deputy Chairman on official duty shall be entitled to re-imbursement of accommodation charge of double room in a Three Star Hotel subject to production of actual payment receipt.

Advances

- 5. (1) The Chairman or the Deputy Chairman shall be entitled to:-
 - (a) an advance of travelling allowances towards the cost of transporting themselves and the member of their families and their family's effect in respect of the journey to Lawngtlai from their usual place of residence for assuming office; and

(b) in respect of journey from Lawngtlai to their usual place of residence outside Lawngtlai on relinquishing office; and

- (c) an advance of travelling and daily allowances in respect of the tour undertaken by them in the discharge of their official duty whether by land, sea or air.
- (d) These advances will be adjusted in the first travelling allowances Bill submitted thereafter.

STATEMENT OF OBJECTS AND REASONS:

The salaries and allowances of Chairman and Deputy Chairman under the provision of the Lai Autonomous District (Salaries and Allowances of the Chairman and Deputy Chairman) Act, 1993 are considered inadequate to meet the present demand in view of the rapid increase of the price index. It is therefore, felt necessary to increase the salaries, allowances and other facilities and privilege of the Chairman and Deputy Chairman of the District Council.

The Bill seeks to repeal the aforesaid Act. Hence this Bill.

further to amend the Lai Autonomous District Council (Salaries and Allowances of the Chairman and Deputy Chairman) Rules, 2003(hereinafter referred to as the Principal Rules).

Be it enacted by the Lai Autonomous District Council in the Sixty Third year of the Republic of India as follows:-

Short title and Commencement.

- 1. (1) These Rules may be called the Lai Autonomous District Council (Salaries and Allowances of the Chairman and Deputy Chairman) (First Amendment) Rules, 2012.
 - (2) It shall be deemed to have come into force with effect from the 1st April, 2012.

Amendment of Rule 3.-

In Rule 3 of the Principal Rules, for the words and figure, "₹ 10,000 (ten thousand)" the words and figure "₹ 40,000 (forty thousand)" shall be substituted.

Amendment of Rule 4.-

Rule 4 of the Principal Rules shall be substituted by the following namely: "There shall be paid to the Chairman and Deputy Chairman a sumptuary allowances of ₹ 6,000 (six thousand) each per mensem, Family allowances of ₹ 5,000 (five thousand) to the Chairman and ₹ 4,000 (four thousand) only to the Deputy Chairman per mensem, and Entertainment Allowances of ₹ 4,000 (four thousand) and ₹ 3,000 (three thousand) respectively."

Amendment of Rule 5.-

- 4. (1) In Rule 5 of the Principal Rules, for the words, "Rental Charge shall not be more than ₹ 3,500 (three thousand five hundred) rupees per mensem," the words "Rental Charge shall not be more than ₹ 5,000 (five thousand) rupees per mensem" shall be substituted.
 - (2) In Rule 5 of the Principal Rules, for the words and figure, "₹ 40, 000 (fourty thousand)," the words and figure "₹ 50,000 (fifty thousand)" shall be substituted, and for the words and figure, "₹ 5,000 (five thousand)," the words and figure "₹ 25,000 (twenty five thousand)" shall be substituted.

- (3) The whole word appearing EXPLANATION with its clauses (i),(ii) & (iii) shall be substituted by the following words, namely:—
 "Provisions of free Supply of Water and Electricity, free Telephone Calls and Payment of Local rates of taxes shall be fixed by the Chairman in the form of Office Order from time to time."
- Amendment of Rule 12.- 5. In Rule 12 of the Principal Rules, for the words and figure, "a fixed pay of ₹ 3,000 (three thousand)," the words "Un-skilled labour rate fixed by the State Government as may be revised from time to time" shall be substituted.
- Amendment of Schedule.- 6. In Schedule (I) of the Principal Rules, for the words and figure, "Daily Allowances of ₹ 250(two hundred fifty) within Mizoram, and ₹ 300/-(three hundred) outside Mizoram," the words and figure "₹ 500/-(five hundred) within District Council area, and ₹ 750/-(seven hundred fifty) outside the District Council area" shall be substituted.

THE LAI AUTONOMOUS DISTRICT COUNCIL
(SALARIES AND ALLOWANCES OF CHAIRMAN AND DEPUTY CHAIRMAN)
(SECOND AMENDMENT) RULES, 2023

Further to amend the Lai Autonomous District Council (Salaries and Allowances of the Chairman and Deputy Chairman) Rules, 2003(hereinafter referred to as the Principal Rules).

Be it enacted by the Lai Autonomous District Council in the Seventy First year of the Republic of India as follows:

1. Short title and Commencement

- (i) These Rules may be called the Lai Autonomous District Council (Salaries and Allowances of the Chairman and Deputy Chairman) (Second Amendment) Rules, 2023.
- (ii) It shall be deemed to have come into force with effect from the 1st day of April, 2023.

2. Amendment of Rule 2

After Rule sub-clause(h) of Rule 2 of the Principal Rules, the following clause shall be inserted, namely:

"(i) 'Deputy Chief Whip' means a person who is appointed as the Deputy Chief Whip of the Lai Autonomous District Council. He shall enjoy all benefits and entitlement (both monetary and assets entitlement) as par with the Deputy Chairman of the Lai Autonomous District Council."

3. Amendment of Rule 3

In Rule 3 of the Principal Rules, for the words and figure, "Rs. 40,000 (Forty Thousand)" the word and figure "Rs. 80,000 (Eighty Thousand)," shall be substituted.

4. Amendment of Rule 4

Rule 4 of the Principal Rules shall be substituted as follows, namely: - "There shall be paid a sumptuary allowance of Rs. 32,000 (Thirty-Two Thousand) to the Chairman and Rs. 30,000 (Thirty Thousand) to the Deputy Chairman per mensem, Family allowances of Rs. 15,000 (Fifteen Thousand) to the Chairman and Rs. 14,000 (Fourteen Thousand) to the Deputy Chairman per mensem, and Entertainment Allowances of Rs. 13,000(Thirteen Thousand) to the Chairman and Rs. 8,000 (Eight Thousand) to the Deputy Chairman per mensem."

5. Amendment of Rule 5

In Rule 5 of the Principal Rules, for the words and figures, "Rental Charge shall not be more than Rs. 5,000 (Five Thousand) per mensem" the words and figures, "Rental Charge shall not be more than Rs. 10,000 (Ten Thousand) for the Chairman and Rs. 8,000 (Eight Thousand) for the Deputy Chairman per mensem, "shall be substituted. Furthermore, for the words and figure, "Rs 50,000 (Fifty Thousand)" the word and figure "Rs. 1,00,000 (One Lakh) shall be substituted and for the word and figure, "Rs. 25,000 (Twenty Five Thousand)" the word and figure "Rs. 40,000 (Forty Thousand) shall be substituted

6. Amendment of Schedule

In Schedule (1) of the Principal Rules, for the words and figure, "Daily Allowances of Rs. 500 (Five Hundred) within the District Council Area and Rs. 750 (Seven Hundred Fifty) outside the District Council Area, "the words and figure, "Daily Allowances of Rs. 1,000 (One Thousand) within Mizoram and Rs. 2,000 (Two Thousand) outside Mizoram," shall be substituted.
