**DRAFT BILL**

On

Chakma Autonomous District Council (Constitution, Conduct of Business etc.) Rules, 2008.

**Rules**

Further to amend the Chakma Autonomous District Council (Constitution & Conduct of Business etc.) Rules, 2002 (hereinafter referred to as the "Principal Rules") as amended from time to time the District Council of Chakma Autonomous District Council in exercise of the powers conferred by sub-paragraph 7 of paragraph 2 of the Sixth Schedule to the Constitution of India and with the approval of the Governor of Mizoram makes the following rules, namely :-

- Short title and Commencement :
- 1) These rules may be called the Chakma Autonomous District Council (Constitution, Conduct of Business etc.) (Amendment) Rules, 2008.
  - 2) They shall come into force from the date of publication in the Mizoram Gazette.

Amendment of Rules 22 (1) For sub-rule (1) of rule 22 of the Principal Rules, the following shall be substituted, namely: "22 (1) There shall be an Executive Committee of the District Council with a Chief Executive Member at the head and six other Members of the Executive Committee to exercise the functions hereinafter specified"
