THE CHAKMA AUTONOMOUS DISTRICT COUNCIL (SALARIES AND ALLOWANCES OF CHAIRMAN AND DEPUTY CHAIRMAN) RULES, 2003. RULES

> To provide for the salaries and allowances of the Chairman and the Deputy Chairman District Council.

Be it enacted by the Chakma Autonomous District in the Fifty Second year of the Republic of India as fullows;

Short Title 1. (1) These Rules may be called the Chakma Autonomous Disand comtrict (Salaries and Allowances of the Chairman and the Deputy mencement. Chairman) Rules, 2003.

(2) It shall be deemed to have come into force with effect from the 23rd May, 2001.

### Definitions 2. In these Rules, unless the context otherwise requires-

- (a) "Chairman" means the Chairman of the Chakma Autonomous District Council;
- (b) "Deputy Chairman" means the Deputy Chairman of the Chakma Autonomous District Council;
- (e) "District Council" means the District Council of the Chakma Autonomous District Council;
- (d) "Family" in relation to the Chairman and the deputy Chairman means the wife residing with him and the legitimate children and step children wholly dependent on him and where the husband has more than one wife, only one wife shall be included in his family;
- (e) "Government" means the Government of Mizoram;
- (f) "He" and its grammatical variation stand for both man and woman;
- (g) "Travelling Allowances" means the allowances granted to the challeman and the Deputy Challman under these Rules to cover the expenses which he incurs in travelling in the interest of public services;
- (h) "Schedule" means the Schedule appended to this Rule;

Salaries 3. of Chairman and Deputy Chairman

There shall be paid to the Chairman and the Deputy Chairman a salary of ten thousand rupees each per mensem.

Sumptuary 4. Allowances, and other Allowances.

There shall be paid to the Chairman and the Dopaty Chairman a sumptuary allowances of rupees four thousand five hundred each per members, Family allowances of rupees four thousand five hundred each per members and the chaertalisment allowances of four thousand rupees and three thousand five hundred rupees respectively.

Residence 115, and furnishing of residence.

The Chairman and the Deputy Chairman shall be entitled without any payment to the use and maintenance of a Turnished residence throughout their term of office and for a period of 15 days immediately thereafter; and so long as such residence is not provided he shall be entitled to a residence for which rental charges shall be not less than three thousand five hundred permises and there shall be made available a such of Rs. 40,000 minutensem and there shall be made available a such of Rs. 40,000 minutensem and there shall be made available a such of Rs. 40,000 minutensem and there shall be made available a such of Rs.

Explanation:-

"Maintenance" in relation to a residence includes :-

- (i) Provision of free electricity and free water supply;
- (ii) provision for free Telephone calls, and
- (iii) payment of local rates and taxes,

Coveyance 6. allowances and use of motor vehicle.

The Chairman and the Deputy Chairman shall be entitled to free use of motor vehicle, the entire cost of maintenance and propulsion along with the services of chauffeur which shall be borne by the District Council.

Travelling 7. and Daily allowances.

Subject to the provision of the Schedule the Chairman and the Deputy Chairman shall be entitled to :-

(a) travelling allowances for the transport of personal effect of himself and his family:-

(i) in respect of journey to Kamalanagar from his usual place of residence for the purpose of assuming office and demitting office. (b) travelling and daily allowances in respect of tour undertaken by him in the discharge of his official duties whether by land or by air.

Medical facilities.

8. The Chairman and the Deputy Chairman and the members of their family shall be entitled free of charge to accommodation in hospital, Nursing Homes and Clinics recognised by the District Council and also to medical treatment, consultation fees and diet charges with one medical attendant in case he is admitted to a Hospital.

No persons in receipt of a salary or allowances under this Rule shall be entitled to receive any sum out of the funds provided by the District Council by way of salary and allowances in respect of their membership of the District Council.

Notification 10.
respecting election of Chairman and Deputy Chairman to be conclusive evidence thereof.

The date on which any person become, or ceased to be, a Chairman or Deputy Chairman shall be published in the Mizoram Gazette and any such notification shall be conclusive evidence of the fact that he becomes, or ceased to be Chairman or Deputy Chairman on that date for the purpose of this Rule.

- 11. The Chairman shall be provided every year in the budget a tionary discretionary fund of the same amount with that of the Chief Executive Member and the Deputy Chairman equal to the amount provided for the Executive Member.
- Household 12. The Chairman and the Deputy Chairman shall be entitled to Grade-IV staffs of three and two numbers respectively of his Staffs. choice as household staffs on a fixed pay of rupees three thousand per mensem and the appointment of them shall be coterminus without yearly increment.
- Repeal and 13. (1) The Chakma Autonomous District Council (Salaries and Allowances of Chief Executive Member, Executive Member, Chairman and Deputy Chairman) Rules, 1983 and all subsequent amendments thereof are hereby repealed.
  - (2) Notwithstanding such repeal anything done or any action taken under the Rules so repealed shall, in so far as it is not inconsistent with the provision of this Rule, be deemed to have been done or taken under this Rules.

## SCHEDULE (see Rule 7)

- Travelling 1. When travelling on duty by Railway or by Road, or by Steamer or on duty. by Air the Chairman and the Deputy Chairman shall be entitled to reimburse the actual fare of journey including incidental charges and daily allowances of rupees 250/- within Mizoram and rupees 300/- out side Mizoram.

Travelling by Air.

- 3. (1) The Chairman and the Deputy Chairman may in public interest, perform journey on tour by Air in transport services.
  - (2) In the cancellation of a journey due to official reason, the Chairman and the Deputy Chairman shall be entitled to be reimbursed by the District Council any deduction made by the Air transport services when refunding the fare on account of cancellation of the Air passage.
  - (3) The Chairman and the Deputy Chairman who does not utilise the free transport service between the Air booking centre and the Airport may also recover in respect of journey to and from the Airport actual travelling expenses or road mileage as as for journey on duty by road which ever is less.

Accomoda- 4. Where no Government accomodation is available the Chairman and the Deputy Chairman on official duty shall be entitled to reimbursement of accomodation charge of double room in a Three Star Hotel subject to production actual payment receipt.

Advance.

- 5. (1) The Chairman and the Deputy Chairman shall be entitled
  - (a) An advance of travelling allowances towards the cost of transporting themselves and the member of their families and their families effect:-
  - (i) In respect of the journey to Kamalanagar from their usual place of residence for assuming office; and
  - (ii) In respect of the journey from Kamalanagar to their usual place of residence outside of Kamalanagar on relinquishing office; and
  - (b) An advance travelling and daily allowances in respect of the tour undertaken by them in the discharge of their official duties whether by land, sea or Air.
  - (2) These advances will be adjusted in the first travelling allowance bill submitted thereafter.

#### STATEMENT OF OBJECTS AND REASONS

The Salaries and allowances of Chairman and Deputy Chairman under the provision of the Chakma Autonomous District Council (Salaries and Allowances of Chief Executive Members, Executive Members, Chairman and Deputy Chairman) Rules, 1983 are considered inadequate to meet the present demand in view of the rapid increase of the price index. It is therefore felt necessary to increase the salaries, allowances and other facilities and privileges of the Chairman and the Deputy Chairman of the District Council.

This bill seeks to repeal the aforesaid Rules. Hence the bill.

#### A RULES

further to amend the Chakma Autonomous District Council (Salaries and Allowances of Chief Executive Member and Executive Members) Rules, 2003 (hereinafter referred to as the Principal Rules).

Be it enacted by the Chakma Autonomous District Council in the Sixty-Third Year of Republic of India as follows:-

#### Short title and commencement

1.

- (1) These rules may be called the Chakma Autonomous District Council (Salaries and Allowances of the Chief Executive Member and Executive Members etc. (Amendment) Rules, 2012.
- (2) They shall come into force with retrospective effect from 1\* April 2012.

#### Amendment of Rule 2.

- 2. After Rule 2 (g) of the principal Rules, the following definition shall be inserted, namely,
  - (h) "Adviser to Chief Executive Member" means a person who is appointed to assist the Chief Executive Member of the Chakma Autonomous District Council in certain functions.
  - (i) "Opposition Leader" means the leader of the opposition members having one-third of the elected members from a single recognised or registered Political Party.
  - "Vice-Chairman (Planning)" means a person who is appointed as Vice Chairman (Planning) of the Chakma Autonomous District Council".

## Amendment of Rule 3.

3. In Rule 3 of the Principal Rules:-

(i) For the words "Chief Executive Member and Executive Members", the words and brackets "Chief Executive Member, Executive Members, Opposition Leader, Adviser to Chief Executive Member and Vice-Chairman (Planning)" shall be substituted.

#### Amendment of Rule 4.

ii) Rule 4 of the Principal Rules shall be substituted as follows, namely, "4 (1) There shall be paid to the Chief Executive Member a sumptuary allowances of Rs. 7,000/-(Rupees seven thousand) only and to Executive Members, Opposition Leader, Adviser to Chief Executive Member and Vice-Chairman (Planning) Rs. 6,000/-(Rupees six thousand) only each per mensem.

(2) There shall be paid to the Chief Executive Member a family allowances of Rs. 6,000/-(Rupees six thousand) only and to Executive Members, Opposition Leader, Adviser to Chief Executive Member and Vice-Chairman (Planning) Rs. 4,000/-(Rupees four thousand) only each per mensem.

(3) There shall be paid to the Chief Executive Member an entertainment allowances of Rs. 4,000/-(Rupees four thousand) only and to Executive Members, Opposition Leader, Adviser to Chief Executive Member and Vice-Chairman (Planning) Rs. 3,000/-(Rupees three thousand) only each per mensem.

further to amend the Chakma Autonomous District Council (Salaries, Allowances and pension of Members) Rules, 2003 (hereinafter referred to as the Principal Rules).

Be it enacted by the Chakma Autonomous District Council in the sixty third year of the Republic of India as follows:-

Short title and commencement

- (1) These rules may be called the Chakma Autonomous District Council (Salaries Allowances and Pension of Members) (Amendment) Rules, 2012.
- (2) They shall come into force with retrospective effect from 1st April 2012.

Amendment of Rule 2.

2. In Rule 2 (g) of the Principal Rules, after the words "Executive Member", the words "Opposition Leader", shall be inserted.

Amendment of Rule 3.

3. In Rule 3 of the Principal Rules, for the words "ten thousand rupees", the words "forty thousand rupees" shall be substituted.

Amendment of Rule 5.

4. Rule 5 of the Principal Rules shall be substituted as follows, namely:-"5. A member shall be paid a constituency allowances of Rs. 3000/- (Rupees three thousand) only per mensem, family allowances of Rs. 3000/- (Rupees three thousand) only per mensem and entertainment allowances of Rs. 1500/- (Rupees one thousand five hundred) only per mensem.

Amendment of Rule 6.

- 5. Rule 6 of the Principal Rules, for the figures "Rs.2,500/-", the figures, brackets and after the words "Rs. 4,000/- (Rupees four thousand) only shall be substituted.
- R Amendment of Rule 7.
- 6. Rule 7 of the Principal Rules shall be substituted as follows, namely:
  "7. A member who occupies own house shall be entitled to receive a sum of Rs. 30,000/- (Rupees thirty thousand) only in the first year for furnishing and Rs. 15,000/- (Rupees fifteen thousand) only annually for the subsequent years of the term:

Provided that payment rate for electricity, calls of telephone, free water supply and local rates or taxes shall be fixed by the Chairman from time to time".

## Amendment of Rule 8.

7. Rule 8 of the Principal Rules shall be substituted as follows, namely:
"8. A member shall be entitled to the service of one Grade-IV staff as personal Attendant according to his own choice and his wages shall be paid as unskilled labour per mensem. The rate of wages of Grade -IV staff shall be revisable from time to time and the appointment shall be co-terminus".

## Amendment of Rule 9.

(1) In sub rule (1) of Rule 9 of the Principal Rules, for the words "two hundred fifty rupees", the figures, brackets and words "Rs. 500/-(Rupees five hundred) only" shall be substituted.

(2) In sub rule (3) of Rule 9 of the Principal Rules, for the figures "Rs. 200/-", the figures, brackets and words, "Rs. 750/- (Rupees seven hundred fifty) only" shall be substituted.

## Amendment of Rule 12.

9. Sub-rule (2) of Rule 12 of the Principal Rules shall be substituted as follows, namely:-

"(2) (a) There shall be paid Rs. 20,000/- (Rupees twenty thousand) only per mensem to a member who had been elected /nominated once for 5(five) year or for any period shorter than 5(five) years.

(b) There shall be paid Rs. 22,000/- (Rupees twenty two thousand) only per mensem to a member who had been elected for three terms or more before the commencement of these rules.

(c) Where any person has been re-elected after the commencement of these rules for another term, whether he has completed the term or not, he shall be entitled to an additional pension of Rs. 3,000/-(Rupees three thousand) only per mensem.

(d) The pension shall be increased at the rate of 5% (five) percent simple interest annually".

 In Rule 13 of the Principal Rules, for the words "one lakh rupees" the words "five lakhs rupees" shall be substituted.
